THE FOUR QUARTERLY EXAMINATIONS

- 1. Division Memorandum No. 190, s. 2016 entitled "Institutionalization of Division Testing Program", calls for the unification of testing in all the schools (Elementary and Junior High School). This will commence this school year specifically on the first QUARTER EXAMINATION.
- 2. In this regard, the target competencies per quarter as stipulated in the Learners' Material (LM), Teachers Guide (TG) and Curriculum Guides (CGs), the number of lessons per quarter are impossible to be covered all by the teachers due to the varied learning abilities of each learner.
- 3. Each English teacher in the Junior High School has to focus on the specific skills/competencies of the following target lessons to be tested per Quarterly examination of the following four grade levels in order to hit the mark.

- 4. It is expected that teachers will focus on the enumerated lessons per grade level and to keep track on the learners' performance through the Daily Lesson Log for instructional decision, whether to reteach the lesson the following day or to move to the next lesson. In addition, DepEd Order No. 8 (re: Assessment Procedures) states that remediation should be done outrightly starting on the fifth week of the first quarter of each school year. Meaning, a teacher doesn't have to wait for the school year to end before he/she remediates. If possible, do remediate everyday if the learners need it.
- 5. As a reminder, the learner's reading abilities is the common denominator of all these. If they are poor at reading and comprehension, surely attaining the mastery level is impossible. CARE and SHARE Program is one of the remedies to this. It is hoped that they also enliven their English classes with the different activities as supplement to the activities introduced in the LMs and more importantly for remediation. Reports of the CARE and SHARE should also be submitted to the division office after every quarterly examination using the monitoring tool.
