Subject: **CONDUCT OF THE SYNCHRONIZED SELECTION OF ATHLETES FOR THE 2016 PROVNCIAL MEET AND SPECIAL GAMES 2016 AND THE NEW COMPOSITION OF THE SPORTS ASSOCIATION IN THE SCHOOLS DIVISION OF ZAMBOANGA DEL NORTE**

Date: **August 17, 2016**

1. In view of the scheduled Provincial Meet and Special Games, scheduled on the **SEMESTRAL BREAK**, it is imperative that the different sports association will be able to field the best athletes possible.
2. To select the best athletes for the different schools, districts, and athletic associations will hold a synchronized athletes' selection activities. The selection will be in three layers: the **school level, district level and the athletic association level**.
3. The schedule of the school level selection will be the immediate first Friday, Saturday and Sunday after the first quarter examination. The district level will be the Saturday and Sunday after the school level selection, and the association level selection will be the Friday and Saturday after the district level selection.
4. To increase competitiveness, geographical grouping and ease in logistics and mobilization, the athletic associations of the division will be organized accordingly, to wit:
 - a. First Congressional District Elementary Schools Athletic Association composed of the districts of Rizal, La Libertad, Sibutad, Piñan, Polanco I, Polanco II, Mutia, Sergio Osmeña I and Sergio Osmeña II.
 - b. First Congressional District Secondary Schools Athletic Association composed of the districts of Rizal, La Libertad, Sibutad, Piñan, Polanco I, Polanco II, Mutia, Sergio Osmeña I and Sergio Osmeña II.
 - c. Second Congressional District Elementary Schools Athletic Association composed of the districts of Katipunan I, Katipunan II, Roxas I, Roxas II, Manukan I, Manukan II, Ponot and Siayan.

- d. Second Congressional District Schools Athletic Association composed of the districts of Katipunan I, Katipunan II, Roxas I, Roxas II, Manukan I, Manukan II, Ponot and Siayan.
 - e. Sindangan Elementary Schools Athletic Association composed of the districts of Sindangan, Central, Sindangan South and Sindangan North.
 - f. Sindangan Secondary Schools Athletic Association composed of the districts of Sindangan, Central, Sindangan South and Sindangan North.
 - g. Third District Mainland Elementary Schools Athletic Association composed of the districts of Bacungan, Salug I, Salug II, Godod, Liloy I, Liloy II, Tampilisan, Kalawit, Labason, Gutalac I and Gutalac II.
 - h. Third District Mainland Secondary Schools Athletic Association composed of the districts of Bacungan, Salug I, Salug II, Godod, Liloy I, Liloy II, Tampilisan, Kalawit, Labason, Gutalac I and Gutalac II.
 - i. Third District Coastal Elementary Schools Athletic Association composed of the districts of Baliguian, Siocon, Sirawai and Sibuco.
 - j. Third District Coastal Secondary Schools Athletic Association composed of the districts of Baliguian, Siocon, Sirawai and Sibuco.
5. The Public Schools District Supervisors are directed to organize the different elementary schools athletic association stated above. The different athletic association when organized, are given the freedom to choose the name of their athletic association provided that the composition remains the same as stated.
 6. The School heads of the different secondary schools are directed to organize the different secondary schools athletic association stated above. The different athletic association when organized, are given the freedom to choose the name of their athletic association provided that the composition remains the same as stated.
 7. The newly organized athletic associations are directed to take charge in the selection of athletes to compete in the Provincial Meet and Special Games.
 8. The Special games will have a selection of athletes depending upon the Special Games Committee with consideration to their special needs.
 9. This memorandum shall have validity until superseded.
