Subject: Division-wide Community Caravan Activities for the Alternative Learning System

Date: January 3, 2017

1. Per Deped Memorandum DM CI-2016 dated October 13, 2016 from Dina S. Ocampo, Undersecretary for Curriculum and Instruction has mandated the conduct of Community Caravan Activities for the Alternative Learning System (ALS) at the Division Level of which **THIRTY SIX THOUSAND PESOS (P 36,000.00)** was downloaded by the national office for this purpose.
2. In line with the above-cited Memorandum, the Alternative Learning System of this Division will be holding a Two-Day Division-wide **COMMUNITY CARAVAN ACTIVITIES FOR THE ALTERNATIVE LEARNING SYSTEM (ALS)** on February 6, 2017 with the following purposes hereunder cited:
  - a) To promote the different ALS Programs and Projects implemented in this Division;
  - b) To gain support from the prospective Stakeholders both Government and Non-Government Organizations for possible financial or material assistance in the implementation of these ALS Programs and Projects;
  - c) To inform prospective ALS learners/clienteles the benefits and advantages of the said ALS Programs and Projects should they avail the same in uplifting their way of life;
  - d) To orient and equip prospective participants with the necessary knowledge and skills in the conduct of advocacy and social mobilization including success stories and true-to-life experiences from the different ALS Passers and ALS Implementers;
3. The said Community Caravan will commenced at Salug Municipal Plaza, Salug, Zamboanga del Norte with an opening program and end at Rizal Municipal Plaza where closing programs/activities shall also be conducted.
4. The above-mentioned activity shall be participated in by all ALS Implementers, and selected learners from the entire division including invited and interested stakeholders.
5. Mechanics relative to the conduct of the said caravan shall be discussed in detail by the Education Program Specialist II- ALS during a meeting of all Implementers called for that purpose.
6. Attendance of all District ALS Coordinators and Mobile Teachers is required during the entire duration of the said activity.
7. Travel expenses of all ALS Implementers (EPS II-ALS, DALSC's and Mobile Teachers) relative to the conduct of the said activity shall be charged against their respective local funds subject to usual accounting and auditing rules and regulations.
