Subject : **REVALIDA OF 2016 PERFORMANCE**

Date : March 29, 2017

1. In line with our continuing advocacy efforts towards strengthening the culture of performance and excellence in this division, this Office has launched *Revalida* in 2016 consistent with the Results-Based Performance Management System (RPMS) of this department. The *Revalida* has provided an open and objective discussion between the management and employees in the performance target setting, monitoring and evaluation.
2. In 2016 *Revalida*, each employee packaged through a Power Point presentation his/her performance beginning April 2015 and ending March 2016 before a panel of evaluators. The panel of evaluators assessed, validated and scored these performances against the standard performance indicators inherent to the position or designation. When the panel deemed it necessary, a school site validation was further conducted.
3. With School Year 2016-2017 closing on April 7, 2017 and in our intention to maintain an open, objective and fair performance evaluation process, this Office realized the necessity to conduct through *Revalida* the evaluation of school head's performance for the period April 2016 to March 2017 on April 17-28, 2017. School heads are hereby informed of this endeavor and are moreover advised to undertake required preparations.
