SUBJECT: EXECUTIVE ORDER NO. 20-38-B

DATE: May 11, 2020

1. Please find attached Executive Order No. 20-38-B – An Order Amending Item III of the Revised Harmonized Guidelines of Executive Order No. 20-38, as Amended by Executive Order No. 20-38-A, issued by Honorable Roberto Y. Uy, Provincial Governor.
2. The amendment requires senior citizens, young individuals, high health risk individuals, including any person who resides with them to remain in their residences at all times, unless extremely necessary under the circumstances. It also enumerates those who are allowed to go outside their residences and that only a valid ID is required to be presented at the checkpoint to be allowed entry or passage thereto.

EXECUTIVE ORDER NO. 20-38-B

"AN ORDER AMENDING ITEM III OF THE REVISED HARMONIZED GUIDELINES OF EXECUTIVE ORDER NO. 20-38, AS AMENDED BY EXECUTIVE ORDER NO. 20-38-A"

WHEREAS, Executive Order No. 20-38, as amended by Executive Order No. 20-38-A, provides harmonized guidelines in the implementation of general community quarantine (GCQ) in the entire Province of Zamboanga del Norte which pursues a uniform implementation of GCQ in all cities and municipalities in the province;

WHEREAS, it has been observed that Item III of the Revised Harmonized Guidelines of Executive Order No. 20-38 as amended by Executive Order No. 20-38-A, particularly Item III A.1 thereof, has been subjected to multiple interpretations and has resulted to non-uniformity of implementation of the GCQ in the province;

WHEREAS, there is a need to clarify and specify the aforesaid item to avoid disparities in the implementation of the GCQ in the province;

NOW, THEREFORE, I, ROBERTO Y. UY, Governor of the Province of Zamboanga del Norte, by virtue of the powers vested in me by the Local Government Code and such other laws, do hereby order:

Section 1. *Item III of Executive Order No. 20-38-A* is hereby amended as follows:

III. MOVEMENT OF INDIVIDUALS WITHIN THE PROVINCE

Movement of individuals shall be limited to accessing basic necessities and work. Everyone is required to stay at home except those who are going to work. Non-workers are only allowed to go out to buy goods and services.

The following persons are required to remain in their residences at all times, except when indispensable under the circumstances for obtaining essential goods and services or for work in permitted industries and offices, viz:

- ***Senior Citizen (60 years old and above)***
- ***Young (0-20 years old)***
- ***High Health Risk Individuals (e.g. pregnant women persons immunodeficiency, comorbidities, or other health risks)***
- ***Including any person who resides with them***

All LGUs shall provide measures to ensure implementation of the above restrictions on the movement of people such as the enactment of necessary ordinances.

Persons allowed to go outside their residences:

- 1. Workers*
- 2. Non-workers who will buy/avail essential goods and services*

Movement of Persons Between Cities and Municipalities within the Province. *It shall be limited only to persons allowed to go outside their residences. The restrictions on the movement of people shall be strictly implemented in every city/municipal checkpoint.*

*Persons allowed to go outside their residences shall ONLY be required to present a **VALID ID (showing the date of birth) or any office/company ID** in every city/municipal checkpoint to be allowed entry or passage thereto. **NO OTHER DOCUMENTS, INCLUDING MEDICAL CERTIFICATE, SHALL BE REQUIRED.***

The limitation of one (1) driver and one (1) helper for the delivery of goods and supplies shall remain.

Section 2. This executive order shall take effect immediately upon signing hereof.

Let copies of this order be furnished to the Provincial Inter-Agency Task Force on CoVid-19, local chief executives, other concerned public and private agencies and institutions, and the mass media for guidance, information, and widest dissemination.
