DepEd Order No. 012, s. 2020, titled "Adoption of the Basic Education Learning Continuity Plan for School Year 2020-2021 In Light of COVID-19 Public Health Emergency", articulates a package of intervention in the delivery of services while ensuring the well-being of personnel at all levels in the Department.
