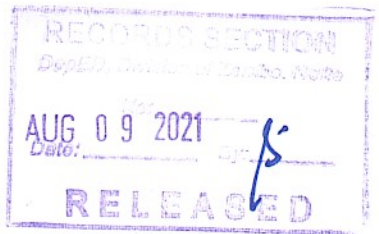

Subject: SIMULTANEOUS SCHOOL *BRIGADA ESKWELA* KICK-OFF PROGRAM AND MONITORING

- With reference to DepEd Memorandum No. 048, s. 2021 *2021 Brigada Eskwela Implementing Guidelines*, the schools division office hereby directs the conduct of the simultaneous School *Brigada Eskwela* Kick-Off Program on August 30, 2021, 8:30 A.M.
- In line with this, all school heads and *brigada eskwela* coordinators are hereby advised to organize a short but significant program consistent with the 2021 *brigada eskwela* theme "*Bayanihan para sa Paaralan.*" The new *brigada eskwela* shall focus on strengthening collaboration and partnership engagements that complement DepEd efforts to implement the Basic Education Learning Continuity Plan (BE-LCP).
