

Pursuant to DO 40 s. 2012 entitled "DepEd Child Protection Policy" and in line with the aspiration to have Child-friendly Schools in the Schools Division of Zamboanga del Norte, we continuously raise awareness, capacitate schools, and mobilize community support for the schools and its learners to ensure a safe and protective space for them.
