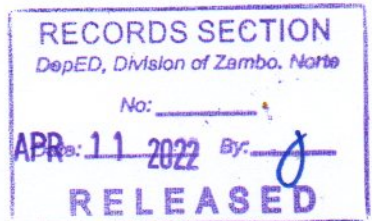

SUBJECT: **SUBMISSION OF THE SCHOOL BASIC EDUCATION LEARNING
CONTINUITY PLAN (BE-LCP) FOR SCHOOL YEAR 2021-2022**

DATE: April 8, 2022

1. To ensure the alignment of all schools to the plans and principles in the delivery of basic education as we return and shift to the limited face-to-face classes and distance learning modalities, all schools are required to submit the revised and final copies of the School BE-LCP 2021-2022 for approval to this office after corrections has been made. The deadline of the submission will be on April 29, 2022.
2. All Public Schools District Supervisors/Principals In-Charge of the Districts shall provide technical assistance on basis of the accuracy of data, suitability of the approaches and directions in revising the said plan to all the schools under them. Hence, each district shall organize a district team of the BE-LCP to review before the submission of the plan on or before the deadline.
3. Moreover, all district heads shall be responsible to review the complete submission of the schools of the soft copies of the said plan through the provided link <https://tinyurl.com/58hpnd5e>.
