EXTENSION OF CLASSES OF THE ALTERNATIVE LEARNING SYSTEM SENIOR HIGH SCHOOL PROGRAM AT SIOCON DISTRICT JAIL

- 1. Relative to the MATATAG agenda of the Department of Education which ensures to **TA**ke good care of learners by promoting learner well-being, inclusive education, and a positive learning environment and Regional Memorandum No. 408, series of 2023 titled "Pilot Implementation of the ALS Senior High School Program", paragraph 3 states that the teachers who will handle the ALS SHS classes are the regular JHS and SHS teachers who are willing to help achieve the dreams of the second chance ALS SHS learners.
- 2. In line with the division ALSENSO SA NORTE-ALS Handog Tungo sa Pagbabago initiative program designed to cater the Persons Deprived of Liberty (PDL) and Children in Conflict with the Law (CICL), the ALS Senior High Program is extending its services to Siocon District Jail of which services are primarily for those Persons Deprived of Liberty (PDL).
- 3. Anent this, to ensure the timely and efficient delivery of quality education to ALS Senior High School learners in special cases/difficult situations, the Principal is hereby directed to facilitate the necessary adjustments for the teachers' schedules who will handle the classes and for the teachers to observe due recognition on the type of learners they are to cater at the Siocon District Jail located at Barangay Manaol, Siocon, Zamboanga del Norte.
- 4. Teachers rendering services in the facility beyond the specified teaching hours shall be granted with service credits pursuant to the guidelines stipulated in DepEd Order No. 53, series of 2003 (Updated Guidelines on Grant of Service Credits to Teachers) not to exceed fifteen (15) work days in a year except in cases authorized by the Secretary upon the recommendation of the Regional Director.
