Change in Schedule and Additional Guidelines on the Administration of the Early Language, Literacy, and Numeracy Assessment (ELLNA) for School Year 2023-2024

In view of the enclosed Advisory from the Office of the Assistant Secretary for Curriculum and Teaching-Education Assessment and Alternative Education, dated April 11, 2024, and in consideration of the intervening activities between April 15 and 19, 2024, this office hereby resets the schedule of ELLNA test administration from April 18, 2024 **to April 25, 2024.**

Corollary to the foregoing, the distribution of the ELLNA test materials to the Chief Examiners or their duly authorized representatives, shall be at the 35 district offices on April 24, 2024. The DTC, assisted by the designated district testing coordinators, shall facilitate the orderly release of the TMs to the dDTCs a day earlier.

The public schools district supervisors/PICDs are enjoined to closely supervise and monitor the ELLNA by then, to preserve the integrity of the test, as well as the propriety of handling and security of test materials (TMs).

The allocation of TMs for all schools is contained in the RE swapping template which can be accessed through **bit.ly/ZNREswapping**,

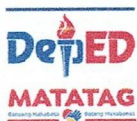

Changes in and Additional Guidelines on the Administration of the Early Language, Literacy, and Numeracy Assessment (ELLNA) for School Year 2023-2024

1. As announced in the Advisory dated April 3, 2024, titled, "*Prerogative of SDOs to Reschedule the Early Language, Literacy, and Numeracy Assessment (ELLNA) and the National Achievement Test for Grade 6 (NATG6) due to High Heat Index Levels*", the testing window for the ELLNA shall be extended from **April 15 to 19, 2024 until April 26, 2024**. However, due to technical, administrative, and operational challenges, two regions (Region IV-A and NCR) shall have a different testing window from the rest of the regions as shown in the table below.

Region	ELLNA Testing Window	Remark
I, II, III, IV-B, V, VI, VII, VIII, IX, X, XI, XII, CAR, CARAGA, BARMM	April 15-26, 2024 (two weeks)	As scheduled
IV-A and NCR	May 13 to 24, 2024 (two weeks)	Rescheduled

The conduct of the ELLNA for SY 2023-2024 was announced in DepEd Memorandum No. 16, s. 2024.

2. Concerning the changes in the testing window, a separate virtual meeting for Region IV-A and NCR shall be conducted by the Bureau of Education Assessment. The details of which shall be announced in another advisory.
3. On the other hand, **all Regional Testing Coordinators and Division Testing Coordinators except those from Region IV-A and NCR** are invited to attend a follow-up virtual orientation regarding clarifications on the delivered ELLNA test materials, particularly about the packing guides and delivery receipts.
