I. CATEGORIES

- A. Individuals: For his/her Community Service or Business and Profession or contribution in the Arts and Culture
- B. Civil Society Organization (CSO)/Non-Government Organization (NGO)
- C. Private and Public Institution (State Universities and Colleges, Banking Institutions, etc.)

II. QUALIFICATIONS:

<ol style="list-style-type: none"> 1. A Filipino citizen; 2. Bona fide resident or must have roots in the Province of Zamboanga del Norte; and 	<ol style="list-style-type: none"> 1. Based in the Province of Zamboanga del Norte; 2. Employees or members of the organizations is composed of at least 80% bona fide resident of Zamboanga del Norte; and 3. Good moral standing with no pending case filed against it.

III. GENERAL CRITERIA:

<ol style="list-style-type: none"> 1. Must have achieved significant accomplishment, or initiated programs and activities that have tremendous contribution to the development of the province; 2. Must exude qualities to inspire the local community especially in various sectors of the youth, women, empowerment, nature conservation and attainment of the sustainable development goals of the UN; 3. Must have exemplified integrity both in public and private life; and 4. Must have brought honor and prestige to the Province of Zamboanga del Norte through accolades and recognition from various organizations based overseas and in the country. 	<ol style="list-style-type: none"> 1. Must have achieved significant accomplishment, or initiated programs and activities that have tremendous contribution to the development of the province; 2. Must exude qualities to inspire the local community especially in various sectors of the youth, women, empowerment, nature conservation and attainment of the sustainable development goals of the UN; 3. Presence of office in Zamboanga del Norte, as main office or branch company compliant to the existing laws, rules and regulations in operation of business and organizations; 4. Must be established for more than 5 years with good track record; 5. Must have exemplified integrity in the community; and 6. Must have brought honor and prestige to the Province of Zamboanga del Norte through accolades and recognition from various organizations based overseas and in the country.

IV. SELECTION PROCESS

1. The nominee must be nominated by a qualified nominator.
2. The Panel of Jurors may invite nominees for an interview and may also ask for additional documentation.
3. Persons, organizations or institutions who were previously recipients of the Zamboanga del Norte Provincial Government's Achiever's Awards no longer accepted for the nomination to give the other individual/ organizations the chance for this year's award; and
4. The decision of the Panel of Jurors is final. Appeals will not be entertained after the awarding ceremony.

2. Information to be included in the nomination form:

- 2.1. Brief description of the nominee: Profile and Performance (up to 200 words).
- 2.2. Highlight the nominee's achievements that you wish to bring to the jurors' attention.
- 2.3. Explanation why the achievements you have highlighted are unique and ought to be recognized.
- 2.4. Reference materials (photo copy, press clippings, work samples, photographs, video clips, etc.) to vouch and provide evidence of the claims you have made in the nomination.

3. For the soft copy, the application form and essay must be in MS Word format, while the other requirements (True Copy of Grades (ICG), certification, pictures, etc.) should be in JPEG or PDF format.
