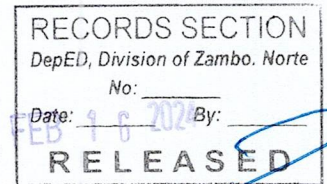

**ONLINE JUDGING OF SCHOOL PUBLICATIONS**

To: Concerned Public Schools District Supervisors  
School Heads (Elementary & Secondary)

1. In support to the Division Reform Agenda under MATATAG Program, and pursuant to its provisions in paragraphs 1-3 re: Modernization and automation to improve the delivery of support services, observance of "Teacher-Field-Centric" Service Culture in the development and implementation of PPAs and maximization and optimization of human and financial resources, aligned with the strategic directions of ABANTE, the Division Schools Press Conference shall be conducted on February 23-24, 2024 at poblacion Liloy, Zamboanga del Norte.
2. In line with this, an online judging of school paper advisers shall be done from February 16, 2024 which is the first day of the uploading/submission of the district winning papers in the provided link and the last day of submission is on February 20, while the last day of judging will be on February 21.
3. As previously practiced, the officers of the ZN Press, Radio and TV Club, Inc. served as judges and resource speakers during the conduct of the Division Schools Press Conference. Unfortunately, these media practitioners are not anymore updated with the latest trends.
4. It is suggested by the Regional Office to utilize the expertise of our school paper advisers who had attended the Regional upskilling in Journalism to serve as JUDGES in both the individual and school paper categories. (Refer to the enclosed list).
5. Hence, this office requests that the school paper advisers in the enclosed list shall be excused from their classes from February 16-21, 2024 for them to have quality time and full concentration in perusing the specific section assigned to them. Instead, they are expected to utilize the available modules and Learning Activity Sheets (LASs) to ensure continuity of learning among our learners.
6. Besides, it is further suggested that the classes of these School Paper Advisers/Judges shall be properly dispensed with to avoid disruption of classes. These SPAs shall be held responsible in finding a location with strong internet connection.

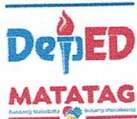
