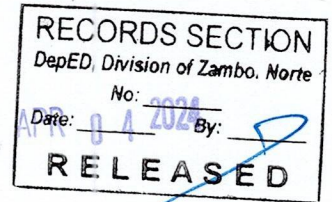

**DIVISION TRAINING OF TRAINERS ON THE MATATAG CURRICULUM
FOR TEACHERS AND SCHOOL LEADERS**

1. The Schools Division of Zamboanga del Norte announces the conduct of the Division Training of Trainers on the MATATAG Curriculum for Teachers and School Leaders on April 15-19, 2024, at a venue to be communicated through an advisory.
2. This activity aims to provide a deep understanding of the general shape of the MATATAG Curriculum in preparation for its phase implementation for Kindergarten, Grade 1, Grade 4, and Grade 7, beginning School Year 2024-2025.
3. The participants are untrained Public Schools District Supervisors, select School Principals, Head Teachers, and Teachers to be identified by the respective PSDS to be indicated in the link <https://tinyurl.com/4jjjfh8d>. It is further advised that each district should adhere to the number of allocated slots. Teacher-participants are preferably master teachers and/or with learning area specialization who can facilitate learning sessions effectively.
4. Participants are advised to check in on April 14, 2024, with dinner as the first meal to be served and to check out on April 19, 2024, in the afternoon.
5. The Curriculum Implementation Division (CID) in coordination with the Human Resource and Development Section (HRDS) will identify the Learning Facilitators and Managers who were already trained at the national and regional levels. The division HRDS and SMME are part of the Program Management Team (PMT).
6. Board and lodging, training supplies and travel expenses of the participants, trainers and management team during the activity shall be charged against continuing appropriation with Sub-Allotment Release Order OSEC-RO-9-ZN-24-03-0144 subject to the usual accounting and auditing rules and procedures.

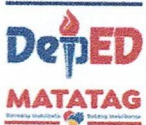
