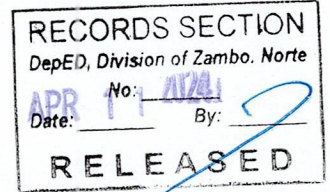

Accommodations, per daily travel expenses and incidental expenses of the select school heads, teachers, coaches and contestants shall be charged to **School MOOE/Local School Funds** subject to the usual government accounting and auditing rules and procedures.” to read as;

“Daily travel expenses and incidental expenses of the Division personnel, PSDSs/PICD, judges, TWGs and ALS teacher relative to the conduct of the said activity shall be charged to **Division Local Funds**, while accommodations, meals, snacks, supplies and materials shall be charged against **Division MEP PSF 2024**. Daily travel expenses and incidental expenses of the select school heads, teachers, coaches and contestants shall be charged to **School MOOE/Local School Funds** subject to the usual government accounting and auditing rules and procedures.”
