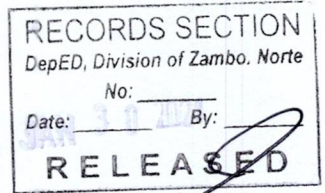

**ADMINISTRATION OF THE 2023 REGULAR PHILIPPINE EDUCATIONAL
PLACEMENT TEST (PEPT)**

TO : **Assistant Schools Division Superintendent

District & School Testing Coordinators

1. The Bureau of Education Assessment, through the Schools Division Office, will administer the 2023 Regular Philippine Placement Test (PEPT) on February 18, 2024 at Sindangan Pilot Demonstration School, Sindangan, Zamboanga Del Norte.
2. The PEPT is administered to learners in special circumstances, namely:
 - a. learners from schools without a government permit
 - b. learners from nonformal and informal education programs
 - c. learners who incomplete or no record of formal schooling
 - d. learners who need grade-level standards assessment
 - e. learners with back subjects
 - f. learners who are overage for their grade levels

Results of this assessment will allow these learners to access or resume schooling and/or obtain certification of completion by grade level in the DepEd formal system.

3. There are fifty-five (55) slots allotted to this division, hence registration of applicants shall be on **first come, first serve** basis. Registration period of interested applicants is February 5-12, 2024. No registration fees shall be collected from the applicant-registrants. The registration form can be downloaded from **bit.ly/PEPTRegistrationForm**.
4. Registrants shall submit the following documentary requirements to the School Management, Monitoring and Evaluation (SMM&E) not later than 5:00 PM of February 12, 2024:

For new applicant

- a. Original and 1 photocopy of Birth Certificate duly authenticated and issued by the Philippine Statistic Authority or by Local Civil Registrar,
- b. Original and 1 photocopy of permanent school records (SF10/Form 137) signed by the school principal/registrar/school administrator,
- c. Endorsement letters from SDO and RO,
- d. Two (2) identical and recent 1 x1 picture with name tags.
- e. Copy of the accomplished PEPT registration form
