CONTRACT AGREEMENT

THIS AGREEMENT, made this ____OCTday of 2023, 2023 between DepEd-SCHOOLS DIVISION OF ZAMBOANGA DEL NORTE, Capitol Drive, Estaka, Dipolog City, Philippines (hereinafter called the "Entity") and MIBANG HOTEL, Sta. Felomina, Dipolog City (hereinafter called the "Supplier").


