CONTRACT AGREEMENT

THIS AGREEMENT, made this _____ day of _____, 2023 between DepEd-SCHOOLS DIVISION OF ZAMBOANGA DEL NORTE, Capitol Drive, Estaka, Dipolog City, Philippines (hereinafter called the "Entity") and YSL BUILDER, Gen. Luna St., Dipolog City (hereinafter called the "Contractor").

 - (k) Other contract documents that may be required by existing laws and/or the Entity.
