CONTRACT AGREEMENT

THIS AGREEMENT, made this DEC 22 2023 day of _____, 2023 between **DepEd-SCHOOLS DIVISION OF ZAMBOANGA DEL NORTE**, Capitol Drive, Estaka, Dipolog City, Philippines (hereinafter called the "Entity") and **YSL BUILDER**, Gen. Luna St., Dipolog City (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor executes the "**Procurement of Projects under the CY 2023 Last Miles Schools Program at Adante Elementary School**" (hereinafter called "The Project") with **Contract No. CB-2023-023** and the Entity has accepted the bid for **TWENTY-FIVE MILLION TWO HUNDRED NINETY-FIVE THOUSAND ONE HUNDRED SEVENTY-FIVE PESOS & 54/100 (25, 295, 175.54)** by the Contractor for the execution and completion of such Project, **within one hundred eighty (180) calendar days** from the **date of receipt of the Notice to Proceed**, and the remedying of any defects therein.

 - (g) Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - (h) Eligibility requirements, documents and/or statements;
 - (i) Performance Security;
 - (j) Notice of Award of Contract and the Bidder's conforme thereto;
 - (k) Other contract documents that may be required by existing laws and/or the Entity.
3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to execute and complete the Project and remedy any defects therein in conformity with the provisions of this Contract in all respects.
4. The Entity hereby covenants to pay the Contractor in consideration of the execution and completion of the Project and the remedying of defects wherein, the Contract Price or such other sum as may become payable
