### INVITATION TO BID

# SUPPLY AND DELIVERY OF TOOLS AND EQUIPMENT FOR TECHNICAL VOCATIONAL LIVELIHOOD PROGRAM OF THE IDENTIFIED TVL-SHS OF ZN SCHOOLS DIVISION

- 1. The Schools Division Office of Zamboanga del Norte, through the Sub-Allotment Release Order No. OSEC -9-18-15233, by RA No. 10964-FY 2018 GAA, intends to apply the sum of EIGHT MILLION, SEVEN HUNDRED SIXTY-EIGHT THOUSAND, NINE HUNDRED SEVENTY-ONE PESOS & 00/00 (Php 8,768,971.00) being the Approved Budget for the Contract (ABC) to payments under the contract for The Supply and Delivery of Tools and Equipment for Technical Vocational Livelihood Program in the Identified TVL-SHS of the Schools Division of Zamboanga Del Norte. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The Schools Division Office of Zamboanga del Norte now invites bids for The Supply and Delivery of Tools and Equipment for Technical Vocational Livelihood Program in the Identified TVL-SHS of the Schools Division of Zamboanga Del Norte. 

  1 Delivery of the Goods is required within Sixty (60) days from Start Date. Bidders should have completed a contract similar to the Project, recently. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

#### In addition:

- (i) Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
- 4. Interested bidders may obtain further information from *Schools Division Office of Zamboanga del Norte* and inspect the Bidding Documents at the address given below during *office hours, Monday Friday* 8:00 5:00PM.

The Schools Division Office of Zamboanga del Norte will hold a Pre-Bid Conference<sup>2</sup> on March 5, 2019, 3:00 PM at the Conference Room, Schools Division of Zamboanga Del Norte, Capitol Drive, Estaka, Dipolog City, which shall be open to bidders who have already bought the bid documents for this project.
- 6. Bids in four (4) copies including the original, must be duly received by the BAC Secretariat at the address below, before 2:30 PM of March 18, 2019. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause Error! Reference source not found.

Bid opening shall be on *March 18, 2019 3:00 PM* at *the Conference Room, SDO, Capitol Drive, Estaka, Dipolog City*. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

- 7. Bidder's are responsible to read all supplemental bulletin/ bid bulletin, as provided in this ITB, and in Bidder's Omnibus Sworn Statement. Procurement timeline as generated by PGGB shall as much as possible be followed. It may however be subject to adjustment with roper notifications, like when quorum cannot be obtained by reason of the inability BAC members due to their official commitments elsewhere.

The *Schools Division of Zamboanga Del Norte* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
