INVITATION TO BID

Printing and Delivery of Alternative Learning System (ALS) Madrasah Education Program (MEP) and Arabic Values Education (ALIVE) in ALS Programs Modules

1. The *Schools Division of Zamboanga del Norte*, through Sub-ARO No. RO-9-ZN-_____ intends to apply the sum of ***Eighteen Million, Two Hundred Thirty-One Thousand, One Hundred Ninety-Three Pesos & 20/100, Philippine Currency, (PhP 18,231,193.20)*** being the ABC to payments under the contracts for *the Printing and Delivery of ALS Madrasah Education Program (MEP) and Arabic Values Education (ALIVE) in ALS Programs Modules with contract Identification Nos. 2020-003CBZNL1 & 2020-003CBZNL2* , for the following lots;

2	Printing and Delivery of ALS, ALIVE, & MEP Modules	PhP 13, 414,230.00

Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.

2. The *Schools Division of Zamboanga Del Norte* now invites bids for the above lot procurement projects. Staggered delivery of the Goods is required to be completed after the periods specifically provided in the schedule of requirements of the PBD. Bidders should have completed, within *three (3) years* from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

4. Prospective Bidders may obtain further information from *the Schools Division of Zamboanga Del Norte* and inspect the Bidding Documents at the address given below during *8:00 AM to 5:00 P.M.*

5. A complete set of electronic/soft copy of Bidding Documents may be acquired by interested Bidders from November 27, 2020 to December 18, 2020 in the given address and website below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **PhP 4,800.00 for Lot 1; PhP 20,200.00 for Lot 2.*** The Procuring Entity shall allow the bidder to present its proof of payment for the fees *either in person, by facsimile, or through electronic means before or upon dropping of proposal.*
6. The *Schools Division of Zamboanga Del Norte* will hold a virtual Pre-Bid Conference¹ on **December 7, 2020 at 3:00 P.M.** via google meet with the link (to be provided later on) which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below **on or before 2:00 PM of December 18, 2020.** Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
9. Bid opening shall be on **December 18, 2020 at 3:00 PM** at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. This Procuring Entity reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
