The Schools Division of Zamboanga del Norte, through the Sub-ARO No. RO-9-ZN-20-08-29B intends to apply the sum of One Hundred Million, One Hundred Fifty-Five Thousand, Seven Hundred Seventy-Two Pesos & 80/100, Philippine Currency, (PhP 100, 155, 772.80) being the ABC to payments under the contract for the Printing and Delivery of Self-Learning Modules (SLMs), for Quarter II, SY 2020-2021 with contract Identification No. 2020-001CBgZN. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The Schools Division of Zamboanga Del Norte, through the FY 2020 (GAA) Funds intends to apply the sum of

being the ABC to payments under the contract for each lot/*item*. Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.

- 2. The Schools division of Zamboanga Del Norte now invites bids for the above Procurement Project. Delivery of the Goods is required by staggered as scheduled to be completed o. Bidders should have completed, within three (3) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country

the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

- 4. Prospective Bidders may obtain further information from *the Schools Division of Zamboanga Del Norte* and inspect the Bidding Documents at the address given below during 8:00 AM to 5:00 P.M.
- 5. A complete set of electronic copy Bidding Documents may be acquired by interested Bidders on October 15, 2020 from the given address and website below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of PhP 8,500.00 for Lot 1; PhP 12, 250.00 for Lot 2; PhP 22, 750.00 for Lot 3, & PhP 6,500 for Lot 4. The Procuring Entity shall allow the bidder to present its proof of payment for the fees either in person, by facsimile, or through electronic means before or upon dropping of proposal.
- 6. The Schools Division of Zamboanga Del Norte will hold a virtual Pre-Bid Conference¹ on October 23, 2020 at 3:00 P.M. via google meet with the link address https://meet.google.com/zfb-wttt-aqt which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below **on or before 2:00 PM of November 5, 2020**. Late bids shall not be accepted.
- 8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
- 9. Bid opening shall be on *November 5*, 2020 at 3:00 PM at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
- 10. This Procuring Entity reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
