That as COMELEC, it is foremost expected that elections of the Division Coordinators for the Supreme Pupil/Student Government is held in a fair, honest and systematic manner.

- That for one to run for any of the positions of the Supreme Pupil/Student Government, each candidate should submit the following documents (DepEd Memorandum No. 17 s.2015) on the first hour of 20 July 2015:
 - Certificate of Candidacy;
 - Parental Consent;
 - 2 2x2 photograph;
 - Official Copy of the Report Card for the Present Academic Year;
 - * Two Recommendation Letters from Two Different Persons Attesting that the Candidate has worked with in a co-curricular or extra-curricular activity.
- 3. That prior to the election of the Division Coordinators, the elections for the Division Federation of the Supreme Pupil Government and Supreme Student Government shall first be held. The following positions for both federations shall be filled in:
 - a. President;

- f. Public Information Officer;
- b. Vice-President;
- g. Peace Officer;

c. Secretary;

h. Representatives of the 1st, 2nd and 3rd

d. Treasurer;

Congressional District

e. Auditor;

Newly-elected officers of the Division Federation of the SPG and SSG shall then elect from among themselves the Division Coordinators - three (3) for the SPG and one (1) for the SSG.

- That all participants are reminded to bring in their school-issued Identification cards as it shall permit admission at the designated polling/voting booth during elections.
- That a general orientation and leadership training will be conducted in the morning of the aforecited date of the event.
