

ENTITLED " SEARCH FOR OUTSTANDING READING TEACHER
FOR ELEMENTARY AND SECONDARY LEVELS "**

Date : February 2, 2017

1. In connection with the Congressional District Level classroom evaluation in the third week of February (February 20-24, 2017) , after the district winners will be declared .selected elementary and secondary school principals will serve as the panel of evaluators in the teacher-contestants' classrooms and in checking the pupils' reading abilities . Besides , they will also serve as observers in the demonstration teaching .
2. Each congressional district will have six (6) evaluators as well as demo observers. .These are three (3) elementary school heads and three (3) secondary school heads . The secondary school heads will take care of the secondary level while the elementary school heads will take care of the elementary level.
3. During the evaluation, the evaluators are expected to let the pupils read words , phrases or sentences and ask them questions to find out if all their pupils could read and comprehend what they read as part of the criteria for evaluation.
4. For the secondary level , all the students in all the sections handled by the contestant teacher in grade 7 shall be interviewed and be asked to read and answer questions .

5. It is a **MUST** that all Master Teachers who handle Grade 2 (for elem.) and Grade 7 (for secondary) will join the competition .

6. Attention is invited to paragraph 8 of Division Memorandum No. 471 and is hereby corrected that the travel expenses of all the school heads who will serve as judges in the congressional district level shall be chargeable to local school funds subject to the usual accounting , auditing rules and regulations.
