NOTICE TO THE PUBLIC

Notice is hereby issued to alert the public of a syndicate issuance of **FAKE** National Certificate (NC) and Certificate of Competency (COC). The public must know that the two certificates which images are shown below, are only issued by the Technical Education and Skills Development Authority (TESDA) after having passed the assessment for the particular competency. The authentic NC or COC is printed in a security paper from the Bangko Sentral ng Pilipinas.

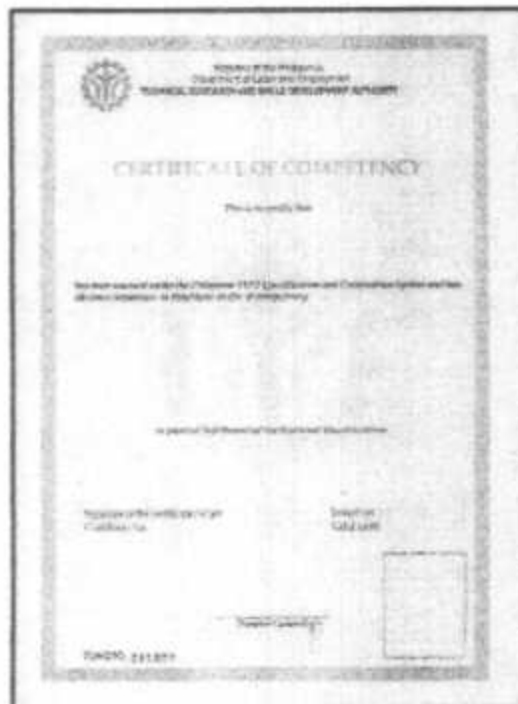
The agency Chief, Secretary Guiling "Gene" Mamondiong reminded the public that distribution and use of fake certificates are against the law and appropriate charges will be filed against those who will be found guilty of involvement in the production/distribution of fake TESDA certificates.
