- Participants are expected to arrive at the venue on or before **1:00 PM of day 0, July 24, 2019** for the registration/settling in of rooms in the hotel. The program and session proper shall then commence at exactly **2:00 PM.**
- Facilitators and staff** are advised to be in the venue at **8:30 AM of July 24, 2019** for the preliminary activities and debriefing.
- Meals and accommodation, fare and honoraria of IP Elders/Resource Persons and non- DepEd Resource Speakers, travel expenses of facilitators coming from the schools/districts, supplies & materials and other expenses relevant to the conduct of the said activity are chargeable against the Division IPED Program Support Funds.
