I. OUAP Last Mile Schools Identification	<i>Schools having indicators enumerated in DepEd Memorandum No. 59, series of 2019</i>
II. OUAP Water	<i>Schools with or without available potable water for drinking, handwashing, tooth brushing, and cleaning for restrooms. Those who do not have will be prioritize for the provision of clean drinking water.</i>
III. OUAP Temporary Learning Spaces (TLS)	<i>Schools that used TLS in holding their classes while repairs and reconstruction are undertaken.</i>
IV. OUAP Flood Prone Schools	<i>Schools with one-storey school building and located in flood prone areas which will be prioritize for 2020 construction of two-storey Administrative and Climate Change Emergency Shelter and Storage Buildings or ACCESS Buildings</i>
V. OUAP Solar Transformer Electrical Upgrades	<i>Schools that have solar panels installed, DepEd-supplied newly installed transformers, upgraded electrical wiring system, or electricity is not stable and needs electrical system upgrading. Upload the photos during conduct of such electrical maintenance and upgrading activity.</i>
VI. OUAP New Furniture- Tables and Chairs	<i>Schools which have received new tables and chairs to send photos or videos of students and teachers using these new furniture in the classrooms</i>
VII. OUAP Abandoned School Building Projects	<i>Constructions were discontinued, no workers present and/or remained unfinished for more than 1 years since project was started</i>
VIII. OUAP Gabaldon Heritage Building Identification	<i>Schools with Gabaldon School building for documentation, validation and consideration as priority for restoration</i>
IX. OUAP School Building Program Prioritization	<i>Schools with facilities that needs immediate repair, additional classrooms, not stable electrical supply, and other needs that have not been provided for the last 3-5 years.</i>
