SUBJECT: **SPECIAL PRONOUNCEMENTS RELATED TO ENGLISH PROFICIENCY TEST (EPT) FOR TEACHER- I APPLICANTS, SY 2020-2021**

DATE: January 24, 2020

1. To clear matters related to the requirement of English Proficiency Test (EPT) for Teacher-I applicants, S.Y. 2020-2021 in this division, the following pronouncements are hereby rendered, to wit:
 - i. Except those applicants who took the EPT in other division, accepting schools **NEED NOT** require applicants to submit and attach in their pertinent documents the EPT Certificate of Rating for the 10 November 2019 EPT, or the 9 April 2019 EPT, since the Division Testing Coordinator (DTC) forwarded right away said results to the Secretariat of the Division Screening and Evaluation Committee, and issued memorandum directing all concerned to a link where they could access the 2019 EPT Results;
 - ii. Schools are enjoined to accept the pertinent documents of those new applicants who for whatever reason failed to take the EPT administered last November 10, 2019. This Office does not discount the possibility that they could still take special EPT which may be administered by any requesting divisions between this month and April 2020, and secure therefrom the EPT results in time for the finalization of the Registry of Qualified Applicants (RQA) 2020;
 - iii. In connection to paragraph ii, all districts thru the PSDSs and assisted by the designated district testing coordinators are enjoined to gather the figure and names
