- The test is computer-based; thus, the e-center or computer room of the host school shall be the testing room;
- All examinees are required to wear school uniform, school ID, ballpen and snacks and/or lunch. A clean sheet of bondpaper shall be provided to the examinees for the computations;
- 4. All examinees are expected to be in the premises of the testing center at around 7:30 or at least one (1) hour before the start of the test. An examinee may be no longer be allowed to take the test if he/she arrives 15 minutes after the start time. He may be replaced by a buffer examinee;
- Gadgets like cellular phones, wrist watch, MP3 and similar devices are strictly prohibited inside the room. These items may be placed inside the bags or be surrendered to the room examiner and will only be retrieved after the test. Bags and other personal belongings should be placed in front;
- Examiners and the members of the technical support team are expected to be in the testing center on or before 7:00 am for the briefing with the DTC representative/s;
- They are likewise expected to administer the test properly, inhibit from bringing their phones inside the testing room or entertaining visitors while the test is going on;
- The examinees shall be given 15- minute break in the morning and in the afternoon, respectively;
- The order of subjects to be taken shall be in accordance with the order as listed in the table under paragraph 1 on this Annex 3;
- 10. As soon as the examinee is through in answering the tests, he /she shall be allowed to go out silently from the testing room. He/she is however encouraged to review his/her answers should and when she/he be finished ahead of time;

ANNEX 4

OTHER PROVISIONS AND RELATED PRONOUNCEMENTS

- Pre Test Preparation. The members of the DTC-RAT Task force, Test Examiners & Technical Support should convene at least 5 days before the test to discuss the details of the test administration and to conduct ocular inspection to the testing centers to ensure the resources are made ready for the tests;
- 2. Set –Up of Examination Room. The testing room should be prepared a day before the scheduled date of administration. Each computer unit which is to be used for the test should be assigned with a number from 1 to 30. If possible, the name of the examinee be placed on the side of the computer table or on the computer set assigned to him/her. List of examinees should be posted on the door;
- Contingency In case of Brown Out. Since the test administration is dependent of
 electricity, contingency over the possibility of power interruption should be laid out. To
 this effect, the host school is directed to coordinate with the RAT Task Force to ensure
 a provision of stand-by generator, which may be borrowed or rented;
- 4. Accommodation of Examinees with their Chaperon/s. Since there are examinees who come from distant districts or schools, the host schools are enjoined to set a room, convenient enough to house the examinees with their chaperons, if any, a night before the test. The school may also provide the same accommodation to those examinees who may request for stay a night after the test, if their travel back to station or home could be delayed;
- 5. Provision of Food and Materials. Examinees, as well as their chaperones are advised to bring their own snacks and lunch packs. The host school is however enjoined to cover against their local funds the provisions of food for the testing personnel, as well as the common office supplies like bond papers which may be used during the test administration, subject to the availability of funds and to the usual COA auditing and accounting rules and regulations;
- 6. Optional Dry Run. Dry Run for at least 30- minutes may be conducted a day before the test to ensure that the examinees may be made familiar with the computer-based process, and to validate the reliability of the online testing system being employed. This is tenable since there will examinees as well as the testing personnel from distant schools arriving a day before the test;
- 7. Expenses of Travel. Expenses that may be incurred in by the members of the DTC-RAT Task Force, testing and support personnel, examinees, teacher-chaperones pursuant to the participation of this test shall be chargeable against division MOOE or local school funds, as the case may be, subject to the usual accounting rules and regulations;
