- Pursuant to Division Memorandum No. 117, series of 2020 entitled "Cancellation of Classes and all Other Activities in Schools" is to be understood that this memo covers all learning centers of the Alternative Learning System (ALS) of this division and thereby encouraging all implementers to refrain from conducting learning sessions where face to face engagement with learners is very crucial in the transmission and spread of COVID 19. This memorandum is in consonance with the Provincial Governor's Executive Order No. 20-24 dated March 14, 2020 suspending classes in all levels in this province starting March 16, 2020.
- With the suspension of classes due to the escalating cases of COVID 19, the Schools Division Superintendent advised all Education Program Supervisors (EPS) to maximize work from home scheme by thinking of ways like assigning learning modules for on line learning and interactions.
- In view of this, with the assistance and full support of Ateneo de Zamboanga University, SUGPAT Team, a partner institution of ALS, Zamboanga del Norte Division on the implementation of Power for Youth Project has come up with the ICT4ALS, an on-line based teaching and learning mechanism utilizing the Contextualized ALS Lifeskills Activity-Based Worksheets readily available for all implementers in this division.
- Along with this development, all Education Program Specialists and Implementers are enjoined to use these materials effective immediately while
