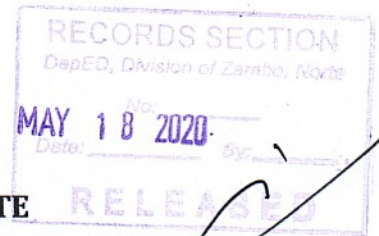




Subject: **Participation to Youth Advertising Contest Organized by the Prosecutor General's Office of the Russian Federation**

BACKGROUND

This has reference to the attached electronic communication from the Department of Foreign Affairs, Office of the European Affairs (DFA, OEA) dated 16 April 2020, informing the Department of Education (DepEd) of an international youth anti-corruption contest, with the topic: "Together Against Corruption", and organized by the Prosecutor General's Office of the Russian Federation.

Submitted entries are expected to reflect modern anti-corruption governmental mechanisms at all levels and aspects of social life, replicating the role and significance of international cooperation in this area. The awarding ceremony for the winners in the two categories will be on 09 December 2020, the International Anti-Corruption Day.

The contest started in 2017, with the invited participants initially coming from the youth of the Russian Federation. Subsequent years showed an increase in invites from international youth participants, the last being in 2019 where over 22 thousand posters and videos were submitted from international participants.

The information on the international youth anti-corruption advertising contest is requested to be disseminated to concerned parties, especially the learners of different grade levels from all the Regions, within the age requirement set by the organizer.

**International Youth Contest
of Social Anti-Corruption Advertising
“Together against Corruption!”**

In 2020 the Prosecutor General's Office of the Russian Federation organizes the International Youth Contest of Social Anti-Corruption Advertising “*Together against Corruption!*” for the young people from all countries of the world.

It is expected that the competent anti-corruption bodies of the States participating in the contest will be the co-organizers of this event.

The contest is open to young people from the age of 14 to 35 years who are invited to prepare contest works on the topic *Together against Corruption!*

The contest works should be submitted from 1st May to 1st October 2020 to the official website of the competition (<http://anticorruption.life>) in two nominations: *The Best Poster* and *The Best Video*. The rules for the contest will be available on the above-referenced website in the official languages of the UN: English, Arabic, Chinese, Russian and French.

The contest works are expected to reflect modern anti-corruption governmental mechanisms at all levels and in all aspects of social life as well as the role and significance of international cooperation in this area.

The award ceremony for the contest winners will be tied to the International Anti-Corruption Day (9 December).

Starting from 2017 the Prosecutor General's Office of the Russian Federation has been organizing social anti-corruption contests, widening the pool of its participants.

In 2017 the All-Russian Contest of Social Advertising “*The New Look on the Prosecution against Corruption*” was held for the young people from all the constituent entities of the Russian Federation who submitted more than three thousand posters and videos.

Such experience of the Russian Federation was welcomed at the international level. In 2018 the International Youth Contest of Social Anti-Corruption Advertising “*Together against Corruption!*” was held in the

framework of the Interstate Anti-Corruption Council together with Armenia, Belarus, Kazakhstan, Kyrgyzstan and Tajikistan during which more than nine thousand contest works were submitted.

In 2019 such contest was organized for the young people from Russia and the other Member States of the Interstate Anti-Corruption Council (Armenia, Belarus, Kazakhstan, Kyrgyzstan and Tajikistan) and the BRICS countries (Brazil, India, China and South Africa). During that contest, over 22 thousand posters and videos were submitted.

We hope that this unique project will increase awareness about the problem of corruption not only among the youth but also among the older generation and will serve the purpose of fostering zero tolerance for corrupt practices in society.

Further information about the contest will be communicated within a special briefing for the diplomatic missions in Moscow at the Ministry of Foreign Affairs of the Russian Federation on the date to be determined. The distinguished missions will be timely updated on the schedule of the event.
