PALIGSAHAN SA MALIKHAING PAGKUKUWENTO

Ang opisina ng Sangay Ng Zamboanga del Norte ay nakatanggap ng liham paanyaya mula sa DSWD Field Office IX hinggil sa pagdiriwang ng ika-28 anibersaryo ng *National Children's Month* na may temang "Sama-samang Itaguyod ang Karapatan ng Bawat Bata sa Panahon ng Pandemya".

Isa sa mga gawain ng naturang ahensya ay ang pagsasagawa ng paligsahan sa "Malikhaing Pagkukuwento" para sa mga batang may **edad 9 hanggang 13** na tatagal mula **Nobyembre 15 hanggang Nobyembre 27, 2020**. Inaatasan ang mga Tagamasid Pampurok na mangunguna sa pagpili ng maging kalahok sa nasabing paligsahan at gagabay sa magulang ng batang kalahok sa pagpapadala ng sipi ng kanyang orihinal na kuwento sa DSWD *official page* bago pa man sasapit ang Nobyembre 27, 2020.

Ang kuwento ay dapat naglalaman o saklaw ang karanasang pampamilya nitong panahon ng COVID-19 at kung paano nalalampasan ng kanyang pamilya ang mga hamon na kanilang kinakaharap. Ang magulang ay magsumite ng *birth certificate* at kasulatang nagpahintulot (*parent consent*) sa bata na sumali sa paligsahan.

Filipino parents and/or guardians are invited to showcase the creativity of their Children ages 9-13 years will be the contestants for this contest. One (1) child per LGUs . The chosen contestant will submit his/her own narration of his/her story to the DSWD official page. The story must cover family experiences during COVID 19 Pandemic and how they were able to cope up with the different challenges. Winners will be chosen based on the given criteria. Parents of the contestant must submit copy of the child's birth certificate and a written consent. Prizes will be given to the deserving winners thru designated courier for provincial PAX.
