SUBJECT: **END OF SCHOOL YEAR EXTENSION FROM JULY 10, 2021 TO JULY 16, 2021**

DATE: June 15, 2021

1. Enclosed is Memorandum DM-OUCI-2021-209 dated June 9, 2021 approving the request of Regional Director Isabelita M. Borres to avail of a one week extension of classes until July 16, 2021 and to move the end of school year from July 10, 2021 to July 16, 2021 for the reasons herein stated.
2. However, there are two (2) options to consider. First, to prefer the previous schedule (July 10, 2021) that is, if the schools' distribution/retrieval of the SLMs as well as the grade computation are done. Second, for schools affected by lockdown, suspension in the distribution and retrieval of SLMs resulting to inability to finish grade computation may opt for July 16, 2021.
