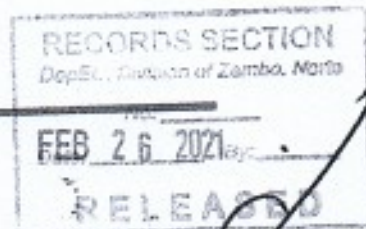

1. As a response to the basic education challenges brought about by this pandemic, DepEd issued DepEd Order No. 012, s. 2020 titled "Adoption of the Basic Education Learning Continuity Plan for School Year 2020-2021 in Light of COVID-19 Public Health Emergency".
