SUBMISSION OF THE SCHOOL BASIC EDUCATION LEARNING

CONTINUITY PLAN (BE-LCP) FOR SCHOOL YEAR 2021-2022

DATE:

August 18, 2021

- 1. The COVID-19 pandemic poses challenges to the delivery of quality education especially in responding educational rights to learners. In order to provide clear guidance to all schools and community learning centers, parents and stakeholders, this office has developed a Basic Education Learning Continuity Plan (BE-LCP) for School Year 2021-2022.
- 2. The Division BE-LCP stands on the following principles:
  - a. Protect the health, safety and well-being of learners, teachers and personnel and prevent the further transmission of COVID-19;
  - b. Ensure learning continuity through K to 12 curriculum implementation, alignment of learning resources, deployment of multiple learning delivery modalities, continuous provision of capacity building for teachers and school heads, and proper orientation of parents or guardians of learners; and
  - c. Facilitate the safe return of teaching and non-teaching personnel and learners to workplaces and schools/CLCs, taking into consideration the scenarios projected by the Department of Health (DOH) and the Inter-Agency Task Force (IATF) for the Management of Emerging Infectious Diseases in the Philippines.
- 3. To ensure the alignment of all schools to the plans and the principles stated above, all schools are required to submit the School BE-LCP 2021-2022 following the same format with the launched Division BE-LCP SY 2021-2022. The deadline of the submission will be on September 15, 2021.
- 4. In developing the BE-LCP, the schools shall engage internal and external stakeholders for inputs of all the desired data, design of the learning delivery strategy and operational direction that ensures welfare to all.

All Public Schools District Supervisors/Principals In-Charge of the Districts shall provide technical assistance on basis of accuracy of data, suitability of the approaches and directions in the crafting of the said plan to all the schools under them. Moreover, each Education Program Supervisor shall also extend assistance to their surrogate districts and monitor the submission of the plan on or before the deadline.
