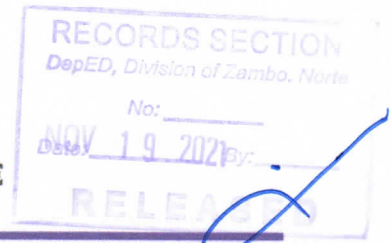

Applicants are required to visit their assigned schools as they will be interviewed via "GOOGLE MEET" platform. The written exam and skills test will be facilitated by the assigned host school personnel. Links for the virtual exercise will be provided by ICT coordinators a day before the scheduled date. PSDSs and PICDS of host districts are requested to be at the venue to provide assistance in case of document verification. (Please see attached list for school assignment)
2. The standards and protocols on promotion and hiring teaching and non-teaching personnel of the Schools Division of Zamboanga del Norte through virtual exercise shall be followed. Internet data costs shall be charged to school funds/budget.
3. Applicants are advised to bring their original and supporting documents on the day of evaluation for verification purposes. The tool provided in **Deped Order No. 66 s. 2007 and DECS ORDER NO. 57, S. 1997 and MEC 10 S. 1979** shall be used in evaluating the documents of applicants for School Admin positions.
