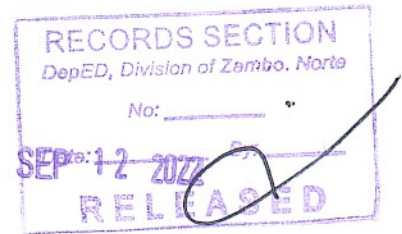

The Philippine Identification System (PhilSys) or National ID was signed into law last August 6, 2018. President Ferdinand R. Marcos, Jr. mandated Philippine Statistic Authority (PSA) to fastrack the National ID as he wants this to be fully functional by 2023.

In response to the recent developments, this Office issued this Advisory, reiterating paragraph 5 and the attached letter from the PSA.

The world is already in the era of digital economy resulting from billions of everyday online connections among the people and businesses. For a country to advance in the digital economy field, it is imperative for a national id to be established.

Philippines Identification System (PhilSys) or national ID was signed into law last August 6, 2018. Pres. Duterte issued EO 162 mandating the integration of the national ID in Citizen's Charters and Private Sector Requirements. Pres. Marcos also mandated PSA to fast track the national id as he wants this to be fully functional by 2023.

PhilSys is digital, inclusive, secure and privacy protecting system. It is a foundational platform on which other systems are built for an inclusive and resilient Digital Philippines. With national id, government and private transactions will be easier. This will be a great help to the Filipinos specially the low income families because the initial issuance is free of charge and has no expiry date and this is a sufficient valid proof of identity.

With those mentioned above, if you would like registration for the non-teaching staff, teachers, pupils, students of all the elementary schools and high schools within your division who are not yet registered, please feel free to contact us, in order for us to prepare and set a mobile registration in the different schools.

Attached is a directive from our National Statistician instructing us to be partners with DEPED in this government endeavor.
