IN PREVENTING CHILD SEXUAL ABUSE FOR LEARNERS WITH
DIFFICULTY IN HEARING THROUGH PERSONAL SAFETY LESSONS
(PSL)**

DATE: October 10, 2022

1. To ensure that all learners be provided with appropriate learning interventions, the Schools Division of Zamboanga del Norte through the Curriculum Implementation Division (CID) in coordination with the Provincial Government Office (PGO) and Center of Prevention and Treatment of Child Sexual Abuse (CPTCSA) a non-profit, non-government child-focused institution will conduct a **DEAF-RESPONSIVE AND RIGHT-BASED TRAINING OF TEACHERS IN PREVENTING CHILD SEXUAL ABUSE FOR LEARNERS WITH DIFFICULTY IN HEARING THROUGH PERSONAL SAFETY LESSONS (PSL)** on October 19-21, 2022 at Royal Farm Resort, Gulayon, Dipolog City.
2. The objectives of this activity are:
 - a. to develop awareness and full understanding of the concepts and strategies in teaching Personal Safety Lessons (PSL).
 - b. to equip the participants with information on how to handle disclosures of sexually abused children.
3. The participants of this activity are the **twenty-five (25) Selected Teachers** (*preferably teachers handling HI Learners*) from elementary and secondary schools of this division. The list of participants is enclosed in this memorandum. This is a live-in activity. The participants are entitled to stay for two (2) nights and three (3) days to attend the sessions.
4. Meals, accommodation and other relative expenditures incurred shall be chargeable against Provincial Government Office (PGO) funds, while travel expenses of the participants shall be charged against School MOOE/Local funds subject to the usual government accounting rules and procedures.
