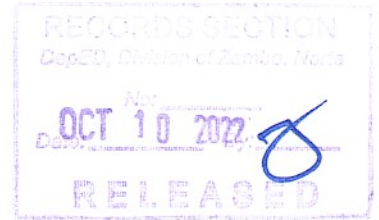

2. PSDSs/PICDs and /or School Head where the vacancy exists are requested to join the Div. Human Resource Merit Promotion and Selection Board per DM No. 355 s. 2022 (New Composition of HRMPSB) during interview proper and document verification virtually.
3. The Standards and Protocols on Promotion and Hiring of Teaching and Nonteaching Personnel of the Schools Division of Zamboanga del Norte Through Virtual Exercise shall be followed. Internet data costs shall be charged to the school funds/budget.

The tool provided on **DepEd Order No. 66 s. 2007** shall be used in evaluating the documents of applicants. 
