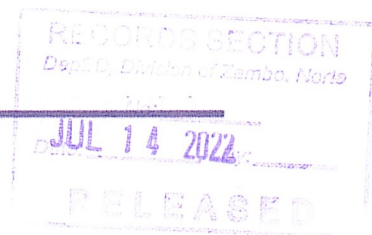



SUBJECT : **COMPLIANCE TO THE TIMELINES AND ACTIVITIES RELATED TO CHILD FIND POLICY FOR LEARNERS WITH DISABILITIES TOWARDS INCLUSIVE EDUCATION (DepEd Order No. 23, s. 2022)**

DATE : July 11, 2022

1. In adherence to the DepEd's thrusts and programs especially on the implementation of the Enhanced Basic Education Act of 2013 (Republic Act 10533) Section 8 which mandates the inclusiveness of education to address the physical, intellectual, psychosocial and cultural needs of learners, the Schools Division of Zamboanga del Norte adopts DepEd Order No. 23, s. 2022 titled, **Child Find Policy for Learners with Disabilities Towards Inclusive Education.**
2. The objectives are set to ensure that learners with disabilities be **identified, located, evaluated/assessed** and **referred** to facilitate their inclusion in the general basic education school system.
3. To achieve these goals, the processes on advocacy campaign or **raising awareness and locating** of the learners with disabilities (*out-of-school children/youth*) aged 5-24 shall be done last week of July to first week of August, 2022. The **screening or assessment** of these learners in the school shall be done on the first week of October. Meanwhile, **teacher-made checklist** and the **Multi-Factored Assessment Tool (MFAT)** shall be utilized in assessing the learners and the Grade 1 entrants for the SY 2022-2023.
