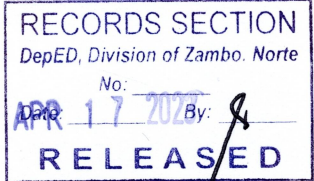

1. The Composition of the Zamboanga del Norte Athletic Association (ZNAA) Delegation to the 2023, ZPRAA Regional Qualifying Meet issued through the Division Memorandum No. 109, s. 2023. 2. The following provision and enclosures are hereby corrected:
 - a. **Paragraph 3** is amended and shall read as: The delegation will assemble at 6:00 AM. at the Schools Division Office area on April 22, 2023. The convoy will depart at 8:30 AM. in going to Pagadian City while the advance party members will travel on April 18, 2023 for the preparation of the billeting quarters prior to the conduct of the activity.
 - b. **Paragraph 6** is amended and shall read as: Travel and other incidental expenses of the ZNAA delegation participants from School to ZN-SDO and from ZN-SDO to school shall be charged against Local/School/MOOE/SEF and other sources of funds while Travel and other incidental expenses of the Advance Party shall be charged against SDO funds subject to the usual accounting, auditing rules and regulations.
 - c. Attached are the corrected enclosures of **provision No. 7** of the Division Memorandum No. 109, s. 2023.
 - d. **Paragraph 8** is amended and shall read as: Service credits and or compensatory Time-Off (CTO) shall be granted for services rendered beyond office hours to those who will be involved in the (Regional Qualifying Meet), subject to DepEd and CSC-related issuances. All applications for service credits shall be checked and reviewed by the Division Sports Officer and Human Resource Management Officer accordingly.




