# CONDUCT OF INTERNAL AUDIT ON THE DIVISION OFFICE'S MANDATED PROCESSES

To: All SDO Office/Unit Heads/Program/Process Owners Members, Internal Quality Audit Team (IQAT)
All Others Concerned

- 1. Consistent with the Division Agenda particularly on Maximization and Optimization of Human and Financial Resources, and cognizant of DepEd Memorandum No. 14, s. 2022 titled The DepEd QMS Manual and Procedures and Work Instructions Manual (PAWIM) in relation to DepEd Order 09, s. 2021 mandating the institutionalization of QMS in the Department, this office seeks to expediate the QMS certification readiness of the division through the conduct of internal quality audit on SDO-mandated processes starting **December 15, 2023**.
- 2. Relative thereto, all SDO program owners are directed to re-calibrate existing office processes to conform with the core and other processes as outlined in the QMS Manual and as detailed in the DepEd Citizen's Charter 2022,1st Edition. Meanwhile, the Internal Quality Audit team (IQAT) are directed to convene and develop a process audit program, plan and itinerary and disseminate the same to all concerned parties not later than December 5, 2023.
- 3. Enclosed, please find the summary of SDO-mandated processes as outlined in the QMS manual, for information, guidance and reference of all SDO program owners and others concerned. As audit priority, the highlighted processes are those with detailed information in the DepEd Citizen's Charter.
- 4. Corollary of the foregoing, the QMS Knowledge Team shall in soonest time possible convene with the PRIME HRM Pillar focals to harmonize the documented PRIME HRM processes with those already captured in the latest edition of the Citizen's Charter.
- 5. Strict adherence to the audit norms and procedures as laid down in the PAWIM is hereby ordered.

6. Widest dissemination of and compliance with this Memorandum is desired.
