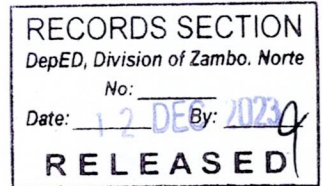

1. In consonance with RA 9155 otherwise known as the Governance of Basic Education Act of 2001, specifically Chapter I Section 7 (5) includes among the responsibilities of the Department of Education (DepEd) across all governance levels the undertaking of educational research and studies that will serve as one of the bases for necessary reforms and policy development. With this ambit, this division will be conducting the First Division Alternative Learning System (ALS) Research Congress on December 20-21, 2023 at Top Plaza Hotel, Dipolog City.
2. The purpose of this activity is to present researches in relation to the context of ALS as one of the components of inclusive education which are evidence-based that will be used to address educational gaps to better improve teaching practices, strategies, andragogical approaches and work engagements so that better support can be provided to teachers and thereby in a way of taking care of the learners as inscribed in the MATATAG agency of DepEd.
3. The check-in time will be at 12:00 noon of December 20, 2023 while the opening program will start at 8:00 o'clock in the morning. First meal will be breakfast of December 20, 2023 and last meal will be breakfast on December 21, 2023.
4. The participation of all concerned to this Research Congress shall be in conformity with the provisions under DO 53, series of 2003 entitled "Updated Guidelines on Grant of Vacation Service Credits to Teachers", where teachers reporting and/or rendering services during Christmas vacation and outside of regular school days shall be entitled with service credits. For non-teaching, when the days of the conduct of the activity will fall on a holiday, they shall likewise be granted service credits. Attached is the enclosure of the list of participants.
5. Traveling and incidental expenses of all concerned shall be charged against the division local funds subject to the usual accounting rules and regulations.
