#### DESIGNATION OF TEACHER-IN-CHARGE IN PUBLIC SCHOOLS

- 1. In relation to Division Memorandum No. 92, s. 2024, particularly paragraph 3, states that "...the Schools Division Superintendent shall designate Teachers-In-Charge in Schools without Principal items, renewable every year and revocable anytime, if necessary."
- 2. Anent this, Public Schools District Supervisors are advised to screen and validate the effectiveness of the Designation Order of the Teacher-In-Charge assigned in your respective schools-districts and to recommend the same to the Schools Division Superintendent as soon as possible teachers to be designated as Teacher-In-Charge of the school adhering to the following principles:
  - Teacher-In-Charge shall be selected from among the Teachers of the same school;
  - By preference, order of priority for the recommendation shall be Teacher III. Teacher II and Teacher I may be considered in the absence of Teacher III or if the same is not interested;
  - The Teacher-In-Charge of the school shall have a regular teaching load;
  - The experience for having designated as the Teacher-In-Charge of the School may be credited under relevant experience for Head Teacher Position subject to the decision of the Human Resource Personnel Selection Board.
- 3. The existing Secondary Schools with designated Teacher-In-Charge are also covered under this advisory and required to comply for re-issuance of their designation.

#### DESIGNATION OF SCHOOL HEAD IN PUBLIC SCHOOLS

Assistant Schools Division Superintendent To: Chiefs (CID & SGOD) Public Schools District Supervisors Public Elementary and Secondary School Heads All Others Concerned

- Pursuant to Chapter 1, paragraph E of the Republic Act 9155, otherwise known as the "Governance of Basic Education Act of 2001", there shall be a school head for all public elementary schools and public high schools or a cluster thereof.
- The school head shall be both an instructional leader and administrative 2. manager. The school head shall form a team with the school teachers or learning facilitators for delivery of quality educational programs, projects and services. A core of non-teaching staff shall handle the school's administrative, fiscal and auxiliary services.
- Anent this, the Schools Division Superintendent shall designate Teachers-In-Charge in schools without Principal items, renewable every year and revocable anytime, if necessary. To become a Teacher-In-Charge, one must have at least three (3) years teaching ~ experience and undergo a screening process to be conducted by the Division Office.
- In the absence of the School Head or Teacher-In-Charge, the designation of a School Officer In-Charge (SOIC), preferably an organic member of the teaching staff, entails a temporary and convenient arrangement intended to avert paralyzation of the day to day operations of the school and is not deemed to include the exercise of discretion as that of a regular incumbent.
