

NDRRMC Memorandum No. 013, s.2024 dated 24 January 2024 outlined the schedule for the conduct of CY 2024 Quarterly Nationwide Simultaneous Earthquake Drill (NSED).

To allow for more meaningful conduct of the Nationwide Simultaneous Earthquake Drill, the Third Quarter NSED is being moved from 12 September 2024 (9:00 AM) to 26 September 2024 (9:00 AM).

In this regard, all DRRMCs at all levels, including the Barangay DRRM Committees, other agencies, and constitutional bodies concerned are hereby enjoined to organize and conduct the abovementioned activity as rescheduled using the worst-case scenarios specific to their areas of responsibility (AORs) to promote earthquake preparedness. Minimum public health precautionary measures must be observed.

Further, all institutions that will participate in the NSED are hereby requested to accomplish the said NSED Participation Data Form and submit to OCD IX at least one (1) day after the conduct of the activity in your localities or offices. Attached is the data matrix for use as a template for your adoption.

Please be reminded that the required data on NSED participants is above and beyond the required submission of the After-Action Report (AAR). Kindly submit the NSED Participation Data Form and AARs through this e-mail address: ocd9cbts@gmail.com.
