NOW, THEREFORE, on motion of Honorable James P. Verduguez, duly seconded by Honorable Jonald C. Napigquit, be it



PROCLAMATION NO. 15

*DECLARING OCTOBER 7, 1988 AND EVERY OCTOBER 7 THEREAFTER
AS SPECIAL NON-WORKING HOLIDAY IN THE CITY OF DIPOLOG*

WHEREAS, the annual "Town Fiesta" of the City of Dipolog is being observed every October 7 of the year;

WHEREAS, to give meaning and ample opportunity to the populace and government officials and employees of Dipolog City to join in the town fiesta, for which planned activities are to be participated in by them;

WHEREAS, for the foregoing purposes, the Honorable City Mayor of Dipolog, in his telegram message dated October 3, 1988, requested for the declaration of October 7, 1988, and October 7 thereafter as Non-working Holiday in the City of Dipolog;

NOW, THEREFORE, by virtue of the powers and authority vested in me by law, as Chairman of the Lupong Tagapagpaganap ng Pook, Autonomous Region IX, I, ELNORITA P. TUGUNG, do hereby declare/proclaim October 7, 1988 and every October 7 thereafter as Special Non-working Public Holiday for and in the City of Dipolog, Province of Zamboanga del Norte.
