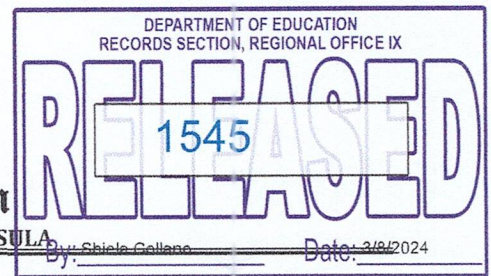

FOR IDENTIFIED PRIVATE SCHOOLS**

1. Pursuant to DepEd Order No. 88, s. 2010 titled 2010 Revised Manual of Regulations for Private Schools in Basic Education, section 25 of the said order states that "All private educational institutions shall be subject to reasonable supervision and regulation by the Department."
2. In view of the foregoing provision, this office has organized the herein attached groups of regional and division personnel to constitute the taskforce on the conduct of regulatory supervision for identified private schools within 15 days from receipt of this issuance.
3. Prior to the commencement of the regulatory supervision, an urgent virtual orientation and background discussion shall be conducted on March 11, 2024 at 9 in the morning. Attendance is a must for this orientation. The link will be sent an hour before the orientation.
4. All expenses incurred relative to conduct of the said activity are chargeable against their respective local funds, subject to the usual government accounting and auditing rules and regulations.
