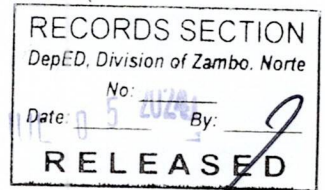

2. The revised schedules and venues are as follow:

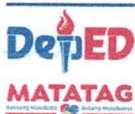

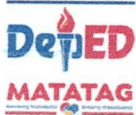
