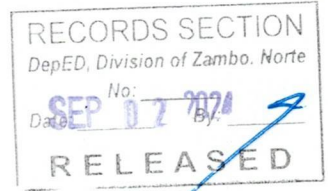

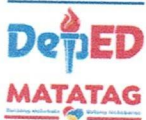
SCHEDULE OF SPORTS ACTIVITIES FOR SCHOOL YEAR 2024-2025

1. The 1987 Philippine Constitution under Article XIV, Section 19, mandates all educational institutions to undertake regular sports activities throughout the country in cooperation with athletic clubs and other sectors.
2. It aims to promote physical education and encourage sports programs, league competitions, and amateur sports, including training for international competitions to foster self-discipline, teamwork, and excellence for the development of a healthy and alert citizenry.
3. In support to this mandate, this Office sets the schedule for the simultaneous sports activities from the School up to Division level, to wit:

School Level	:	September 25-26, 2024
District/Municipal Level	:	September 26-30, 2024
Legislative District Level	:	November 25-29, 2024
Division Level (ZNAA)	:	December 04-07, 2024

4. However, schools-district may opt to deviate from the recommended dates provided that **no disruption of regular classes of participating student-athletes** is being observed during the preparations including training of athletes pursuant to DepEd Order No. 9, s. 2005 "*Instituting Measures to Increased Engaged Time-on-Task and Ensuring Compliance Herewith*". It is advised that Public Schools District Supervisors, Districts and Principals In-Charge shall monitor the conduct of the above-stated activities and encourage all private schools in their respective districts to participate in sports activities from the school level up to higher levels of athletic competition.

Contextualized Guidelines in the conduct of Sports Activities from the School Level up to Zamboanga del Norte Athletic Association (ZNAA) Qualifying Meet (Division Meet)

1. Schools shall organize their sporting events based on their strengths and available resources such as sports equipment, trainers and qualified coaches including playing/ training grounds;
2. Athletes must have undergone the Physical Fitness Test (PFT) and must be physically fit in joining sports activities. They should be members of the School Sports Club in their respective schools;
3. Age requirement for athletes are the following:
Elementary: Born January 1, 2012
Secondary: Born January 1, 2007
4. In case of transfer of learner-athlete, the following rules shall apply:
 - a. For transfer of athlete from one region to another region, a one (1) academic year or school year residency requirement shall be imposed, which shall commence at the beginning of the school year except for those in Grade 7 and Grade 11. This provision shall also apply to Filipino student-athletes from other countries enrolling in a school in the Philippines.
 - b. For individual event- transferees from one school to another school within the Division or transferees from one Division to another Division within same Region are allowed to participate in the higher sports competition, provided, they have participated in the lower meets (School, District, Municipal, Legislative District and Division Meet).
 - c. For team events (Basketball, Baseball, Futsal, Sepak Takraw, Volleyball, Softball and football)-A student-athlete who transferred from one school within the Division or Region, shall be allowed to participate in the Palarong Pambansa, provided his/her transfer was made before the conduct of the school intramural.
5. For team events, a Winner-Take-All Policy shall be implemented in all levels of sports competition; (Athletes must be enrolled in one school only)
6. For individual and dual events, athletes are required to meet the Qualifying Time Standards (QTS) to be indicated in a separate Division Memorandum;
7. Preparations including the training of athletes shall be done after class hours or during weekends to avoid disruption of classes as stipulated in DepEd Order No. 34, s. 2022;
8. Adherence to the provisions of DepEd Order no. 9. S. 2005 (Instituting Measures to Increase Engaged Time-On-Task and Ensuring Compliance Therewith) and Child Protection Policy is hereby enforced during the preparations and practices of student-athletes and game proper.
9. Ensure the presence of Medical team and DRRM personnel in all levels of sports activities;
10. Extravagant opening program is strongly discouraged;
11. All sporting events shall be played in accordance with the rules and regulations set by the Department of Education.
