- 1. The District Disaster Risk Reduction and Management (DRRM) Team, led by the Public Schools District Supervisors (PSDS), is tasked with overseeing and monitoring the responses from all schools within their respective districts to ensure that schools requiring assistance are accurately accounted for.
